INTRODUCTION

NEW FEATURES AND ENHANCEMENTS

Note: You will need to complete the *****Action Required***** items (where applicable) to make sure your system functions properly with this updated version.

As with all updates, for all new menu functionality, you will need to identify which users you want to have access to the new menu functions. Then, you must activate the new menus using the *Model User Menus* function located on the *System, User Management* menu. You must also set the security level that you want on the new menus using the *Change Function Security* function located on the *System, User Management, Function Security Menu*.

Billing

Review/Send Electronic Statements (Billing > Review/Send Electronic Statements)

Made the following enhancements to the summary screen, to provide additional information and for practices that have CGM webPAY™; identify accounts that have a credit card on file.

- Added a **CC Status** column - *****CGM webPAY Clients Only***** The following credit card statuses will display a:
 - Green Dot if the account has a valid credit card on file.
 - Yellow Dot if the account has a credit card on file that is going to expire soon (based on **Days to Warn for CC on File Expiring** setting in the *CGM webPAY Integration* function).
 - Red Dot if the account has a credit card on file that is expired.
 - White dot with line if the account does not have a credit card on file.
 - Note:** The **CC Status** will only appear in databases with CGM webPAY enabled and only for the current statement file (not historical files).
- Added an **Acct Balance** column - Displays the account balance at the time of the statement.
- Renamed the **Balance** column to **Pt Balance** - Displays the Patient Balance at the time of the statement. Prior to this change, the Balance column was actually displaying the patient balance, so the contents of this column have not changed, only the name.
- Added a **Last Stmt** column - Displays the date of the last statement for this account.
- Last Pt Pmt Date** column - Displays the date of the last patient payment on this account at the time of the statement.
- Added a **Last Pt Pmt Amt** column - Displays the amount of the last patient payment on the account at the time of the last statement.
- Added a **Last DOS** column - Displays the last date of service at the time of the statement.
- Added a **Print to Excel** Action Column button, which will print the contents of the summary screen to Excel.

Billing (cont.)

Insurance Filing Report (Billing > Insurance Billing Functions > Insurance Filing Report)

Added **Microsoft Excel via MyReports** option in the Printers selection window.

In addition to the standard data provided, the Excel version includes separate columns for:

- **Printed** - Prints **Yes** or **No** to indicate if the insurance claim was printed or not.
- **Ins Code** - The Insurance Carrier Code for the claim.
- **Ins Description** - The Insurance Carrier Description for the claim.
- **Ins Form** - The Insurance Form Type stored for the Insurance Carrier Code.
- **Function** - Indicates the function used to create the claim.
 - **C** = Create Insurance Print File function
 - **P** = Procedure Entry function
 - **S** = Secondary Filing generated by response from primary carrier
 - **T** = Tertiary Filing generated by response from secondary carrier
 - **A** = Delinquent Insurance File Create (Automatic refile)
 - **E** = Electronic submission (moved to paper)
 - **D** = Insurance on Demand function
 - **R** = Refiled
 - **JP** = Transfer Journal to Current File or a Transfer Journal to Paper Claims
 - **F** = File a Claim - When the File or Demand action is performed from within Encounter view. **Note:** This code is recorded for a Demand action only when the claim has not been previously filed.
 - **JP** = Journal to Paper - When the Transfer Journal to Paper Claims function is performed.
 - **X** = Automatic Refile - When paper claims are created using the Create Delinquent Insurance function.
 - **H** = On Hold - When a date is entered in the Claim Hold field in Procedure Entry.
 - **XP** = Exceptions to Paper - When an electronic exception is moved to the Paper File.
- **Claim Type** - Prints Primary, Secondary or Tertiary

Removed the **Path Name if Work Document** field, since it is no longer used.

Work Accounts (*Collections > Patient Collections > Work Accounts*)

Added a **Print to Excel** Action Column button.

Print Collection Roster (*Collections > Patient Collections > Print Collection Roster*)

Enhanced the *Microsoft Excel via MyReports* function to include a 'Worked' column with 'Y' or 'N' to indicate if the account has been worked or not, if you select to print for 'All' accounts.

Print Roster Summary (*Collections > Patient Collections > Print Roster Summary*)

Enhanced the report so you can print it to *Microsoft Excel via MyReports*.

Print Dead-End Report (*Collections > Patient Collections > Print Dead-End Report*)

Enhanced the report so you can print it to *Microsoft Excel via MyReports*.

Print Collection Letter Statistics (*Collections > Patient Collections > Print Collection Letter Statistics*)

Enhanced the report so you can print it to *Microsoft Excel via MyReports*.

Turn Over History Report (*Collections > Patient Collections > Turn Over Functions > Turn Over History Report*)

Enhanced the report so you can print it to *Microsoft Excel via MyReports*.

Print Collection Roster (*Collections > Insurance Collections > Print Collection Roster*)

Enhanced the report so you can print it to *Microsoft Excel via MyReports* and added a 'Worked' column that will print with 'Y' or 'N' to indicate if the account has been worked or not, if you select to print for 'All' accounts. In the standard printed report, changed the **Insurance Balance** heading to **Acct Bal** and changed **Delinquent** to **Delinq Ins Bal** to make it clear which balance is printed. When printed to Excel the column headings will print **Acct Balance** and **Delinquent Ins Balance**.

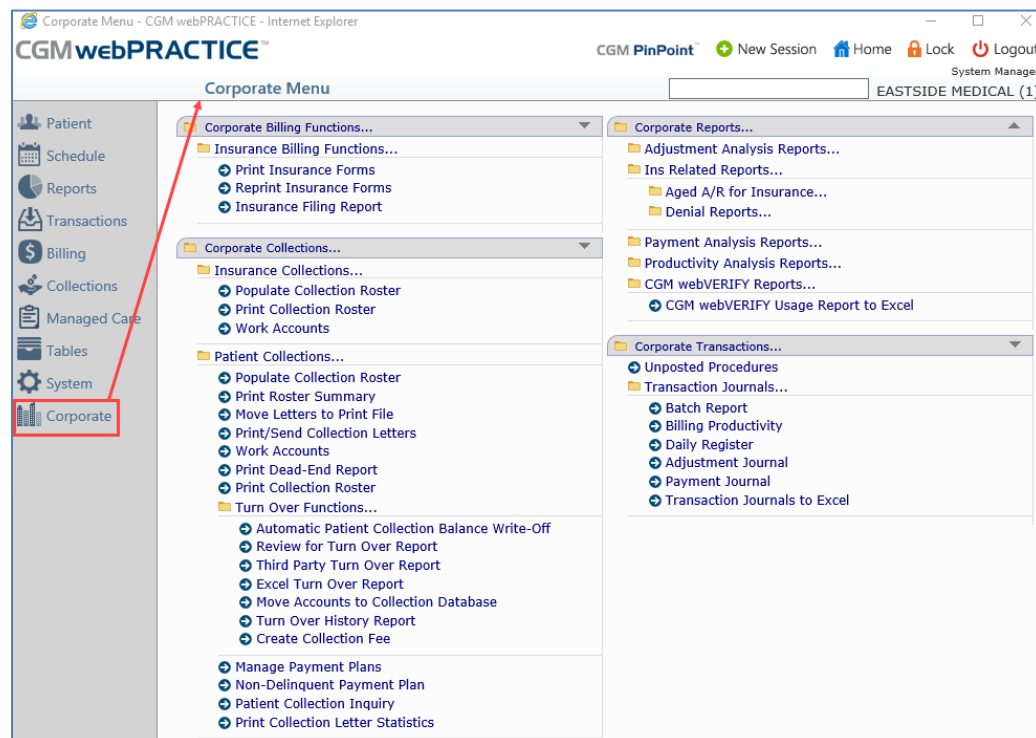
All Corporate Functions

In the 2021.1.0 update, we had removed collection databases from the database selection screen, but that change has been reverted since some clients do still need access to them.

Note: If you accessed any of the corporate functions and selected databases in the Database Selection screen after the installation of the 2021.1.0 update, those databases were set as your 'default' selections and were defaulted the next time you accessed the screen. Your default selections will remain intact and this modification will not affect you.

Corporate Functions

Added a new **Corporate** main menu to make it easier to access every corporate report and function. Every function that was previously on the *Reports > Corporate Reports* menu was moved to the new menu and placed on the appropriate sub-menu. New menu functions were also added for Corporate Insurance Collections and Corporate Patient Collections.



Corporate (cont.)

General notes for Corporate functionality:

- *User Database Access* function must be set up for each User (*System > User Management > User Database Access*)

It is required that tables to be shared in order for the reports to function accurately. If tables are not shared:

- If the report encounters a table code for one of the selected databases that does not exist in the Table in the database you are currently logged into, 'undef' will print on the report - along with the totals for that 'undef' code. This alerts you that you may need to go in and manually update your database(s) with these missing codes.

- The report sorting option is only going to provide table items that exist in the database that you are logged into when printing the report.
- If any additional sorting options are selected within the lead-in screen, the report is only going to provide results for the databases that actually contain the selected code(s) in their tables. Keep in mind that the table code could be different for one database vs another database.
- If the additional sorting options within the lead-in screen are left blank, the report will provide results for all codes across all databases, but if a table code exists in more than one database it will provide the name of the table item for the first database it finds with that table code. Keep in mind that the table code could be different for one database vs another database, but the different names for the table code will not be present in the report.

Corporate (cont.)

Due to the quantity of enhancements made to the Billing, Insurance Collections and Patient Collections functions to provide Corporate functionality, the following definitions have been provided to prevent repetition in the release notes:

Definition of Corporate - Report

Includes a Database selection screen.

The report footer will print **Requested by** (User) and **from** (Database Name (DB#)).

Print Here functionality

- Will print a separate report for each database you selected.
- The report heading will contain the Database Name and Number.

Microsoft Excel via MyReports option in the Printers selection window or Print to Excel.

- The report heading will print the Database Numbers you selected.
- Includes columns for the Database (number) and Database Name.

Definition of Corporate Function

Includes a Database selection screen.

Includes a Database Summary screen that lists all of the selected databases, so you can easily work each database from a single access point.

Database Summary screen includes a **Print to Excel** Action Column button. The Excel report includes a Database (number) and Database Name column.

When possible, the Database Summary screen provides a column(s) that lists the total(s), so you can easily keep track of the databases you have worked. To access a database, click anywhere in a Database row. Follow the standard process and when you are done, you will automatically return to the Corporate Database Summary screen.

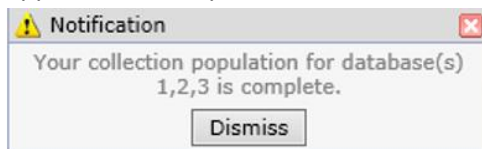

Populate Collection Roster (*Corporate > Corporate Collections > Patient Collections > Populate Collection Roster*)

Turned into a corporate function, so you can populate the patient collection roster for multiple databases at the same time. Upon accessing the function, the corporate database selection screen displays. After selecting the databases that you want to populate, they will start populating in the background and display the status on the screen.



After all of the selected databases have started populating, you can click **Proceed**. A notification message appears in the top left of the screen when the patient collection roster has populated for all databases.

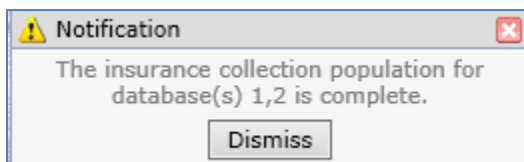

After selecting the databases that you want to populate, they will start populating in the background and display the status on the screen.

Post No-Show Appointments (*Schedule > Post No-Show Appointments*)

Enhanced the function to post no-show appointments based on the option selected for the **Post No-Shows Based On** field in the **Scheduling System Integration** function (*System > Database Maintenance Menu > Integrations > Schedule Integration > Scheduling System Integration*). Added a **Post No-Shows Based On** field, so you can choose between either **Superbill #** or the Check In/Out Status of the patient's appointment to determine when no-show charges should be posted.

- **Check In/Out Status** - If you want to post No Shows for appointments based on Check In/Out Status Codes, select this option. This would only post No Shows for appointments that have not been saved with any Status Code (*Schedule > Patient Status/Location Table > Maintain Status/Locations*) that has the **Check In/Out Status Code** check box selected.
- **Superbill #** - If you want to post No Shows for appointments based on Superbill #'s assigned to appointments, select this option. This would only post No Shows for an appointment that had a superbill printed but no subsequent charges entered in Procedure Entry.
