NEW FEATURES AND ENHANCEMENTS

Note: You will need to complete the *****Action Required***** items (where applicable) to make sure your system functions properly with this updated version.

As with all updates, for all new menu functionality, you will need to identify which users you want to have access to the new menu functions. Then, you must activate the new menus using the *Model User Menus* function located on the *System, User Management* menu. You must also set the security level that you want on the new menus using the *Change Function Security* function located on the *System, User Management, Function Security Menu*.


General Enhancements

Printing Tables


The functions on the following menus related to printing tables have been enhanced, so you can now choose to include inactive codes.

- *Tables (Print)*
- *Schedule > Scheduling Table Maintenance (Print)*
- *System > User Management > Maintain Users (Print)*

To include inactive codes when printing a table, you need to select the sorting parameter of *Active/Inactive*. If you don't sort by *Active/Inactive*, only active codes will be included.



If you want to print only Inactive codes, you can Begin and End Sort with "Inactive". Example:



Note: These changes only apply to tables that use the "standard" printing functionality. Standard tables in the system always have the same lead-in screen - showing the field to select Long or Short format, Sort Parameter, and Begin and End with Sort fields. There are some "non-standard" print functions on the Tables menu that were not changed, example: *Print the ANSI CARC/RARC Table*.

System

CGM webPAY Integration (*System > Database Maintenance Menu > Integrations > CGM webTOOLS Integrations > CGM webPAY > CGM webPAY Integration*)

A **Payment Vendor** field has been added to allow the changing of the Payment Vendor between eMEDIX or TSYS. This will prevent any downtime from occurring when transitioning from TSYS to eMEDIX when collecting payments using CGM webPAY.

Maintain ANSI CARC/RARC Codes (*Tables > ANSI CARC/RARC Table > Maintain ANSI CARC/RARC Codes*)

The updated Claim Adjustment Reason Codes (CARC) and Remittance Advice Remark Codes (RARC), effective July 1, 2024, have been released.

Load the HCPCS Codes (*Tables > Procedure Code Table > Load the HCPCS Codes*) *****Action Required*****

Updates to the 2024 HCPCS data files, effective July 1, 2024 and October 1, 2024, are available for loading. To receive the updated codes, you must load the 2024 file.

Import RVU Unit Values (*Tables > Relative Value Schedule Table > Import RVU Unit Values*) ****Action Required****

The Centers for Medicare and Medicaid Services (CMS) have updated the 2024 Medicare Relative Value Unit files (RVUs) effective July 1, 2024, and October 1, 2024. To receive the updated codes, you must load the **2024** file.

Load the AMA CPT® Codes (*Tables > Procedure Code Table > Load the AMA CPT® Codes*)

The 2024 **PLA** CPT codes effective July 1, 2024, are available. The PLA codes are Vaccine Specific CPT Codes for Coronavirus Immunizations and can be loaded by selecting the **Pathology** and **Lab** code category.

Import Fee Schedules (*Tables > Fee Schedule Tables > Import Fee Schedules*) *****Action Required*****

The Centers for Medicare and Medicaid Services (CMS) have released the following Fee Schedules:

- 2024 Medicare Physician Fee Schedule, effective July 1, 2024
- 2024 Medicare Clinical Laboratory Fee Schedule, effective July 1, 2024, and October 1, 2024.
- 2024 Medicare DME Fee Schedules; Prosthetics/Orthotics and Supplies (DMEPOS), effective July 1, 2024, and October 1, 2024.

The updated files are available for import by selecting 2024 in the **Fee Schedule Year** list and the applicable file name in the **Fee Schedule File** list.

Load ICD-10-CM Codes (*Tables > Diagnosis Code Table > Load ICD-10-CM Codes*) *****Action Required*****

The updated ICD-10 code set, effective October 1, 2024-September 30, 2025, is available for loading. This code set is included, so you are **not** required to purchase it.

Tables (cont.)

Import and Post ERA Files (*Transactions > Electronic Remittance Advice (ERA) > Import and Post ERA Files*)

The updated CAQH CORE code combinations for Claim Adjustment Reason Codes (CARC) and Remittance Advice Remark Codes (RARC) and the associated Business Scenarios have been updated. The mandatory compliance date for the updated codes is January 1, 2025.

Maintain Doctor Codes (*Tables > Doctor Code Table > Maintain Doctor Codes*) and **Maintain Group Taxonomy Numbers** (*Tables > Doctor Code Table > Provider Number Table > Group Taxonomy Number Table > Maintain Group Taxonomy Numbers*)

The updated Taxonomy Codes, effective July 1, 2024, have been released.
